ENTRY METHOD: FIRST RECEIVED

ENTRIES OPEN: Wednesday, February 19, 2023. at the Trial Secretary's address. All entries received before this date will be returned. Overnight or certified mail must be sent with the "No Signature Required" waiver signed.

ENTRIES CLOSE: Wednesday, May 3 2023, at 6 PM after which time entries cannot be accepted, cancelled, altered, or substituted except as provided for in Chapter 11, Section 6 of the Rules Applying to Dog Shows.

Envelopes/transactions containing entries for more than the ten (10) dog maximum and/or entries received prior to the opening date shall be treated as an invalid entry and shall be returned to the sender.

Paper entries received within 24 hrs. of the opening date & time must: 1) include postage or be metered; 2) be delivered by a multi-state or multi-national postal or carrier service, including but not limited to USPS, FedEx, UPS & DHL. If above conditions are not met, the entries are not valid and must be returned to the sender.

The Trial Secretary is not responsible for entries not received or cancelled by specified dates. Please refer to the official AKC rule books to make sure you understand the rules set forth for entering AKC Agility Trials.

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

Entering for Exhibition Only (FEO)

FEO allows exhibitors to work with their dogs in a trial environment. FEO is only offered in the Time 2 Beat and FAST classes. Participation in FEO is non-qualifying.

FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.

Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.

Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.

The exhibitor must declare FEO in the ring prior to leading out. FEO may

be declared earlier (ex. when checking in at the gate board). Toys are allowed in the ring. Toys must be non-audible and may not leave the handler's hand. Toys that roll freely may not be used.

Food/treats are not allowed in the ring.

FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and /or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.

A judge must monitor the entire run. Judges can stop a run at any time.

Fix and Go On

FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score. Fix and Go On is not pre-entered; rather, it occurs during the run.

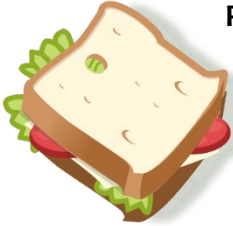

HEIGHT DIVISIONS

Effective January 1, 2010, exhibitors are no longer required to provide proof to Trial Secretaries that their dog has a valid jump height card as part of the check-in process. Furthermore, this change eliminates the need for a copy of the jump height card to be submitted with an entry form. Dogs without a valid Jump Height Card/Form may still compete; but they must be measured/wicketed by the **Judge of Record** PRIOR to running in their class and this measurement will be valid for that weekend of trials only. The exception to this requirement is a dog entered in the 24" or 26" height division. However, if a **Volunteer Measuring Official (VMO)** or an **Agility Field Rep** is present; **ALL** dogs without a valid Jump Height Card/Form must be measured at some time during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure the dog **before** its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in

COURSE FAMILIARIZATION

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. A warm-up area, consisting of a regulation agility jump, will be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training the dog.

OBSTACLES & TIMING

Obstacles will meet the specifications for obstacles in the current edition of the Regulations for Agility Trials. This trial will be held indoors, ring Dimension 78' x 105' with self-closing gates. Electronic timing devices will be used.

ROUTES TO THE TRIAL

From I-83:

I-83 to Exit 32 (Newbery exit). **Northbound** – At the light at the bottom of the ramp, turn left onto Rt. 382 North to Lewisberry. Go approximately 3 miles to the flashing traffic light and turn left onto Rt. 177 South toward Rossville. Go approximately 4 miles and turn right on Mt Airy Rd (across from Gifford Pinchot State Park). Continue approximately 1.7 miles to the site on the left. **Southbound** - At the light at the bottom of the ramp turn right onto Rt 382 North to Lewisberry. Follow directions above.

EXHIBITOR INFORMATION

From US-15:

Take Bowmansdale exit Rt. 114 towards Ski Roundtop. At traffic light at the bottom of the hill, proceed straight on South Market St. DO NOT FOLLOW 114. Continue straight about 2.3 miles on South Market St which will become North York Rd. Turn left on East Mt. Airy Rd (at Mt. Pleasant Church of God) and go approximately 4.5 miles. You will pass Ski Roundtop on the right. Continue to a "T" intersection and turn right on Pinetown Rd. Take the first left onto Mt Airy Rd. Site is immediately on the right.

SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The club, Bella Vista and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The club and/or BVTC reserve the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the BMDCA, BVTC or any official thereof.

All dogs must be on leash at all times when on trial grounds except when in the designated warm-up area or competing on the course.

All regulations governing the use of this facility, and all regulations and decisions of the trial committee at this trial will be strictly enforced, including and not limited to the recorded information of this premium list.

Puppies under 4 months of age are prohibited at AKC Agility Trials.

The Club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

ENTRY ELIGIBILITY

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number (in trials offering mixed breed entries), or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number (in trials allowing mixed breed entries) must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs should be physically sound. Dogs that are blind or deaf shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate.

Move-Ups

Per American Kennel Club Regulations for Agility Trials, dogs may be moved up to a higher class, at the request of the owner, as a result of qualifying for an agility title. Before the trial, move-ups may be made prior to the move-up deadline via email to trialsec@bvtrainingcenter.com or USPS in writing to the Trial Secretary at 730 Mt Airy Rd, Lewisberry, PA 17339. Verbal move-ups will not be accepted. Move-ups are due in writing by Monday, May 15, 2023.

FCRSA/BVTC reserve the right to change the running order to improve the efficiency of the trial.
A final general running order will be included in the Final Confirmation.

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

All refund requests will be processed by the Flat-Coated Retriever Society of America.

CRATING and SEATING

Crating will be restricted to the Annex Building. The Show Site Committee reserves the right to alter crating arrangements for space purposes. Exhibitors are responsible for the conditions in and around their own crating area. Tarps must be placed under all crates. Dogs will not be permitted to stay overnight in the crating area.

Limited seating space will be available at ringside. Please no oversized chairs, reclining chairs or tables in this area. Please, no dogs permitted in front row.

RINGSIDE

Dogs may arrive any time prior to judging. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running. All dogs not needed for further judging will be excused. Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

PARKING

Exhibitors are governed by any rules or regulations of civil authorities and building and parking regulations. Vehicles parked contrary to regulations will be subject to towing at owner's expense. PLEASE NOTE: A limited number of handicap spaces are available. They will be available on a first-come basis. A valid handicap plate/placard must be on each vehicle using these spaces.

RV/OVERSIZED VEHICLE PARKING: RV's and Oversized Vehicles are not allowed to park in the regular parking spaces. Oversized Vehicles are defined as those vehicles that do not easily fit in a parking space either by width or length. No trailers.

Club officials may require that vehicles or equipment be rearranged to accommodate additional

vehicles. Area around vehicles MUST be kept clean at all times. All vehicles will be parked at owner's risk. BVTC & ABA will not be responsible for loss by burglary, fire, or any other cause whatsoever to the vehicle or its contents.

Leashes

All dogs must be on leash at the trial. Retractable leashes are not allowed in the building. Dogs may only be off leash while running the course or at the practice jump. No exhibitors or dogs are allowed behind the row of pine trees to the rear of the Arena.

ALL BVTC Policies are in effect.

OFFICIAL AMERICAN KENNEL CLUB AGILITY TRIAL MOVE-UP FORM

From Chapter 1, Section 20: Move-Up entries will be accepted for dogs that have completed a title after the closing date. Email notification of move up or class change is acceptable, with return receipt verification from the secretary. Either Move Up forms or emails must be completed and delivered to the Trial Secretary prior to 6 PM, on the move up date. Move-up entries for the next day must be delivered to the Trial Secretary within 30 minutes of the conclusion of judging of the class they are moving up from. Dogs so moved up will run at the end of the running order.

From Chapter 1, Section 21: After the close of entries, a dog which has been entered in a class for which it is not eligible for, due to class restrictions on the dog or handler may be moved to the correct class under the following conditions: The request for the move must be in writing and presented to the superintendent or the trial secretary at least 30 minutes prior to the start of each trial. (ie, Master to Excellent, or Novice A to Novice B, or any other class. Moves between regular and preferred divisions are not permitted after the trial closing date.)

Entry move-up valid only if the dog was already entered in the Event indicated and only if approved by the Trial Secretary. Dogs moved up will run at the end of the class running order.
